A graduate of The University of Texas' acclaimed Radio-TV-Film department, Michael continues to give back to the dance community by nurturing and educating aspiring dancers through guest master classes all over the world, with yearly visits to Australia, Japan & Europe. He was on faculty at the world-renown EDGE Performing Arts Center in Hollywood for three years and is currently on faculty with the legendary Tremaine and Hectors/Dance Caravan Convention Tours where he is able to connect with young dancers across the United States and speak to them about realistic expectations in professional dance. In Feb/Mar2009, Michael completed his most intensive teaching tour to date; a 40-workshoptour of the entire continent of Australia in 16 days and 7 cities!

Michael is also the Founder and Creative Director of FUSION entertainment [[www.fusionentertain.com](http://www.fusionentertain.com)], an LA-based company that provides choreography, dancers and cirque-style specialty acts for live events. FUSION has become a commodity in the event world, creating awe-inspiring production numbers for various corporate industrials and special events across North America.

As a dancer, Michael has worked with Craig David, Britney Spears, Jennifer Lopez and Graham Norton. Michael has conceptually consulted Aerosmith/ABC Live, The Latin Grammy Awards and Avril Lavigne. He has choreographed live corporate industrials for PUMA, Skechers, Bravo!, Jafra Cosmetics, Charles Schwab, Whole Foods and has worked on commercials for MGM Mirage, Palm Treo, Land Rover and Mitsubishi. Most recently, Michael directed aerial performers for Sheryl Crow's concert at the MGM Grand in Las Vegas, choreographed the Music Video Production Awards, both The Beach Boys and LeAnn Rimes televised halftime show performances, the Allstate BCS College Championship Bowl, promotional performances for Cyndi Lauper, Lucy Lawless & Kristine W, Norwegian Cruise Lines and "Jambalaya" the new live spectacular at the Wyndham Bahamas Resort. Michael has choreographed music videos for UK sensation Mis-Teeq, BMI's Latin crossover Roselyn Sanchez, Universal Records new band Taxi Doll, Brian Anthony's soundtrack videos from the films Garfield 2 & Fantastic 4-Rise of the Silver Surfer and many Euro-Pop artists. In 2008, Michael was a guest choreographer for the CBS reality series Big Shot Live, choreographer/stage director for the Miss USA and Miss Universe TV specials on NBC, choreographer for the Alamo Bowl halftime show on FOX, and most importantly, co-choreographer and director for Lady GaGa's first major live TV performance of "Just Dance." In 2009, Michael continues his work with NBC on Miss USA and Miss Universe and has staged live TV performances for breakout artists The Veronicas ("Untouched") and Kevin Rudolph ("Let It Rock").

# EIU PANTHER SPORTS CLINIC INFO

**HEALTH and INSURANCE:** Each participant must have a **Health & Consent Form** signed by a parent/guardian, stating participant is in good health and who to contact in case of an emergency. **This form is included in this brochure.** Form is also available online at our summer camp link at [www.EIUpanthers.com](http://www.EIUpanthers.com). This form must be completely filled out, **signed** and returned to us, along with application. The remaining **BALANCE IS PREFERRED** at least seven (7) days prior to the beginning of class.

**EIU requires that all sports clinic and camp participants carry health insurance coverage.** The parent/guardian's personal or injury insurance policy will be utilized as the primary insurance for the treatment of injuries and hospitalization for illness or injuries incurred during the sports camps. The name of health insurance carrier (and policy number) must be written on the **Health & Consent Form** in order to attend an EIU sports clinic or camp.

If you do not possess health coverage, or are self-insured, a temporary policy **MUST** be purchased (through your insurance agent) to cover the participant for the duration of the sport clinic/class/camp.

Cancellations made seven days prior to on-campus registration may receive a refund less \$10, by submitting a request (in writing) to the athletic office within 30 days after the date of the class.

After on-campus registration has been completed, there will be **NO REFUNDS** for early withdrawals, non-attendance, or disciplinary dismissals.

**FACILITIES:** The master classes will be held on the campus of Eastern Illinois University in Charleston, Illinois, in the Student Recreation Center, located next to the Lantz Gymnasium.

**WHAT TO BRING:** Participants should bring towel, appropriate dance apparel and shoes, water bottle, money for lunch/snacks, and other necessary items to attend class.
